Requirements when Applying For A Marriage License in the U.S. Virgin Islands.

**1. MARRIAGE APPLICATION FORM
TO BE COMPLETED BY
APPLICANTS (TYPE)**

- a. Full name, age at last birthday
- b. Social Security Number
- c. Date of Birth
- d. Nationality; Usual Residence
- e. Name of Parents (present/maiden place of birth)
- f. Previous Martial Status (widowed, divorced, marriage annulled)

After completion, please return the application to the Court. Applications must be typed. Any application that is not typed will be returned to the applicants. If applicants have been divorced, it is required that a certified copy of their divorce decree be filed along with the application. Applicants should attach a letter with the application detailing:

- a. Date of Visit
- b. Length of Stay
- c. Date of preference if desirous of having the marriage performed by a judge

2. POSTING OF APPLICATION

Virgin Islands law requires that “[b]efore any marriage license is issued, the application for such license shall be posted for public examination in the Office of the

Clerk of the Court for eight (8) days.” The law contains an exception, however, for “special cases.” If you will not be present in the Virgin Islands for eight (8) days preceding your marriage ceremony, you may be exempted from the posting requirement under the “special cases” exemption. Thus, applicants presenting these or similar circumstances may be granted a marriage license without having to comply with the posting requirement. If you need an exemption from the eight-day posting requirement, check the appropriate box on the application form and include a brief explanation of your reason for the request in the space provided.

**3. EXAMINATION OF APPLICANTS FOR
MARRIAGE LICENSE**

Before a Marriage License can be issued, applicants are required to personally appear before the Clerk of the Court, or her designee, to be examined under oath.

- a. Some form of identification is required.
- b. No physical examination or blood test is required.

The Clerk will then notarize your application. Please do not have application notarized prior to appearing before the Court.

4. FEES

All fees are to be paid by certified check, money order or by cash when paying in person. The fee for filing a Marriage Application is \$50.00 which is “non-refundable” and the fee for the Marriage

License is also \$50.00. If the marriage is to be performed by the Judge of the Territorial Court, there is an additional fee of \$200.00 for the marriage ceremony. Marriages are performed Monday through Friday, except holidays. A date and time will be scheduled by the Court upon arrival. The Court cannot make arrangements for churches. Applicants will have to write directly to the denomination of their choice if they wish to be married by a clergy.

OFFICE HOURS

Office hours are 8:00 a.m. through 5:00 p.m. Monday through Friday. The Court is also open on Saturday between the hours of 10:00 a.m. to 12:00 p.m. Additionally, by pre-arrangement, and upon payment of a \$150.00 surcharge per couple, the Court will be available on Sundays and specific holidays between 9:30 a.m. and 10:30 a.m. The Court will not be open for any business on:

ATTIRE

Although your attire may be casual, wearing apparels such as slippers and shorts are *not permitted* when appearing before the Court.
